Approval of the minutes of the previous BOD meeting-

The minutes of the 4th QTR October 15, 2025 GNBPC BOD meeting was approved.

Financial Budget Review:

- Budget for 2026 adjusted to \$1300.
- Donations from Monday Jan. 12 meeting will not be included in the budget, but will be included in the Actuals. Photo services will not be included either. Donations amounted to \$505.
- Art Council Membership dues - \$100
- PSA Membership - Dues due in April, they are for 1yr- \$45, 2-yrs \$85, 3-yrs \$120. It was agreed to pay 3 years this time.
- PO Box fee - Being used for IRS, Bank Statements, and PSA Journal. Adjusted budget to \$200.
- FotoSeptiembre insurance - \$75
  - Leave drink budget at \$0 for this year.
- Zoom - \$170
- Go Daddy - \$23 due Annually, due in February
- Wix - Due in June. \$220.83
- Christmas Party fees were discussed. Possibly will partition the donations from the 1/12/25 meeting being used towards this cost. We will wait until we get closer to the party to decide how the party will be planned. We will discuss more details about the fees/budget around this at the next club meeting. Possibly organize a Christmas Party planning committee.
- Youth Tournament - \$100
- Site Builder was removed from the budget, we no longer use that service.

-Social Media, we will start training for backups to help Taryn.

-PSA Submissions and Club Submissions, pixel size requirements. We agreed not to vote on this right now to change our club submissions requirements because it will be more work for Taryn.

-Voting will be closed at a certain time set by Taryn via email.

-Next board meetings tentatively set as April 16, July 16, and October 16. These days can be adjusted as needed when we get closer.

-Presentation ideas were brainstormed for the regular meetings, other than reviewing images.

-Confirmed that we have the same meeting room from January for February and March as well.

-Considering adding an additional description to the monthly slides to explain the monthly assignments a little more with a short sentence/paragraph.

The meeting was adjourned at 8:25 pm.
